MERRIMACK VILLAGE DISTRICT BOARD OF COMMISSIONERS MARCH 26, 2020 MEETING MINUTES (approved April 20, 2020)

A regular meeting of the Board of Commissioners was conducted on March 26, 2020 at 3:30 p.m. at 2 Greens Pond Road, Merrimack, NH.

REGULAR SESSION

1. Board of Commissioners to discuss Capital Projects with Underwood Engineers to include:

a) ESR #49 – Well #2 – Final Design

Keith Pratt, of Underwood Engineers, informed the commission that ESR #49 is to advance the Final Design Phase related to the engineering at Well 2. This is to advance the PFAS treatment facility at and for Well 2 and does not include the raw water transmission main or anything at Well 3. ESR #49 includes the Final Design, surveying the project site, subsurface geotechnical work, borings and probes, and a geotechnical report, as well as soils analysis for the building and infiltration basin. Also included is permitting work, an RSSCT at Well 2, and bidding services.

It was noted that the facility at Well 2 will be designed to accommodate expansion if other sources are to be treated at this facility to the extent possible. This means provision for additional building space to be added.

At this time Commissioner W. von Schoen questioned the "work not included" listed on page 6 or the ESR. K. Pratt noted that under this section, the design of treatment other than GAC

facility for PFAS treatment recognized that there was no iron and manganese facility going in. The right of way has already been recognized, and the future construction phase is done in another engineering contract. K. Pratt also noted that water quality sampling or analysis should be corrected because the pilot study was added, so analysis will take place under the RSSCT.

K. Pratt informed the commission that ESR #50 included a system-wide SCADA evaluation and radio assessment, corrosion control evaluation and chemical feed optimization, and a master plan update for source options.

K. Pratt noted that Underwood is waiting on one number from TCS on the radio evaluation. Without numbers, no further action can be taken on ESR #50.

It was noted that work on Well 3 has stopped. Underwood Engineers will provide a final report documenting the movement and decisions for Well 3.

c) ESR #51 – Well 4/5 – Technical Assistance with SGPP Negotiations

K. Pratt informed the commission that ESR #51 is an allowance for attendance at monthly commissioner's meetings, prepare cost opinions, summarize technical information, assistance in preparing materials for and participating in meetings/negotiations with Saint Gobain Performance Plastics (SGPP) and any other work requested by the MVD in reference to the SGPP negotiations.

d) ESR #52 – Well 7/8 Bidding

K. Pratt informed the commission that ESR #52 regards bidding services for Wells 7 & 8. Underwood is ready for bidding on these wells once authorization is provided. P. Pitsas noted that NH DES approval is needed. K. Pratt recommended that should the MVD make a motion to approve ESR #52, they couple it with the approval to bid pending NHDES approval.

K. Pratt noted that due to the effects of COVID 19 things, such as pre-bid meetings, would likely be done in an unconventional manner (conference calls, etc.). It was also noted that it is important to solidify whether work on the infrastructure would be deemed essential, by the Governor's orders. A letter requesting exemption will be sent.

2. Board of Commissioners to discuss next steps for Emery & Garret/GZA's Sodium and Chloride Reduction Project.

Jamie Emery noted that Emery & Garret/GZA has been asked to do chloride measurements in areas around Wells 2, 3, 4, 5, 7 and 8. Emery & Garret identified the storm drains, the direction the storm drains were flowing, as well as where the storm drains were discharging. J. Emery informed the commissioners that storm water run-off, including the salt load from parking lots, was found to be discharging in the areas of the MVD wells. J. Emery specifically noted high levels in the region of wells 2 & 3, and wells 4 & 5. The data shows high salt loads in the areas where the state of NH DOT plows the roads. It was also noted that the areas of wells 7 & 8 show much lower chloride levels, showing that salt measures are being abated in that region. J. Emery stated that he would like to put together a proposal for the next MVD Board of Commissioners meeting. J. Emery also noted that he feels as though he has the data to go before the state in order for changes to be made.

Chairman D. Provencher recommended that Jamie Emery includes in his forthcoming scope of work a task to meet with DES to present his findings to them, and to ask for DES's support at a future meeting with landowners located within the wellhead protection areas.

Additionally, J. Emery informed the commission that drilling of new well 4 would take place on March 30, 2020.

At this time, Commissioner W. von Schoen noted that he would like a list of all ESRs with the budgeted values and the billed to date values. He stated that he felt this was important to track. Superintendent R. Miner noted there is a similar document available and he would be able to supply this to the board. Chairman D. Provencher noted that he would like to include details summarizing the outstanding ESRs from both Underwood Engineers and Emery & Garret, as well as how the bill-to-date amount compares to the ESR budget. He would also like to categorize which ESRs are applicable to the engineering amount that was included in the warrant articles. Superintendent R. Miner noted that something similar already exists and will be provided to the board along with the budget reports that align with each project.

3. Board of Commissioners to assign Commissioners to speak to individual Warrant Articles and to review the procedure for the Annual Meeting on March 31, 2020.

Business Manager J. Lavoie informed the commission that the annual meeting is only allowed to be postponed in two-week increments. The annual meeting was initially scheduled for March 31, 2020 and has been postponed until April 14, 2020. Given the Pandemic, New Hampshire's Governor, Chris Sununu, has waived the requirement that annual meetings take place by May 1, 2020. Governor Sununu has also made an allowance for the notice of the annual meeting to mark the location as "To Be Determined."
