BILLING RATES/SERVICE CHARGES

MVD's rates are based upon the type of service for each location.

Domestic (Residential) water bills consist of the following:

- **Meter Charge** – Cost is determined by the meter size for the water service location. Water service locations with multiple units served by one meter are charged per unit (refer to Section 9 of MVD By-Laws).
- **Water Usage Charge** – Cost for all water passing through the meter; whether used, wasted, or lost by leakage.
- **Hydrant Charge** – For structures, buildings, or units within a six hundred (600) foot radius of a hydrant. Locations with multiple units are charged per unit (refer to Section 9 of the MVD By-Laws). This charge applies regardless if the property is provided water service by MVD.

Mercantile & Industrial water bills consist of the following:

- **Meter, Usage, & Hydrant Charges as listed above**
- **Fire Protection Charge** – For structures, buildings, and/or units that are connected to a fire protection service line. Cost determined by the size of water line.

NEW WATER SERVICE ENTRANCE CHARGES

New 3/4" and 1" Water Service Entrance Rate includes all fittings to connect and tap into the MVD water main up to the first valve/curb stop. The cost of meter(s) and installation in excess of 1" inch will be paid by the applicant/user. Final approval of the installation is subject to inspection by MVD prior to water service turn on. An inspection fee during regular business hours (minimum one hour) is included in the entrance. Any additional or after-hours inspections will be charged based upon current schedule of rates.
